

**Bearded Lady Bourbon® “Win an Arcade Racing Machine”
Promotion Terms & Conditions**

How to Enter Details:

To enter for the chance to win 1 of 2 Daytona USA arcade racing machines, consumers must purchase a 700ml bottle of Bearded Lady Bourbon® or any Bearded Lady Bourbon 4pk RTD containing the competition QR code during the Promotional Period from any participating store; and enter at beardedladybourbon.com, answer the question “In 10 words or less, tell us why you deserve a Daytona USA machine” take a photograph of your receipt, validate your age and complete the entry form details online. Entry is open to Australian residents aged 18 years and over. Maximum one entry per person, per day.
